

2. Mr Wayne Bergmann was not available to make a recommendation regarding the proposed resolution due to travel and work commitments, however Mr Bergmann is noted to have an interest in the outcome of the resolution due to being a listed entity in a personal capacity and as a director/operator of Mad Jam Mad PTY LTD.

All other information

- 3. Whilst not all of the listed entities are currently related parties of the WAC, each of the listed parties is either a Nyikina and/or Mangala Person or Nyikina and/or Mangala owned and operated business. Through new appointments to the WAC board of directors, these parties are considered likely to become WAC related entities. It is on that basis that the WAC proposes to ensure that it is permitted by its members to enter into contracts for services with these parties, should they become related parties before 31 December 2026.
- 4. Three new entities¹ have been added to the list of entities that were approved by the WAC members at the last WAC annual general meeting to receive related party benefits in the same form as proposed in this notice. Those previously approved entities are re-listed in this notice to ensure WAC's compliance with s 284.1(1)(a)(ii) of the Corporations (Aboriginal and Torres Strait Islander) Act 2006 (Cth) which requires WAC to give the benefit within 15 months of receiving the WAC members' approval.

 - "To achieve relief from poverty, misfortune, disadvantage and suffering of the Native Title Holders."

ORIC COMMENTS OF 18 SEPTEMBER 2025

Explanatory statement

To comply with section s290-10(c) an explanatory statement should set out the nature of the financial benefits the corporation proposes to confer. A description of a 'contract for services' and a description of the type of services to be provided does not sufficiently characterise the nature of the financial benefit. While the total contract amount would satisfy this requirement, if this is not known with a degree of certainty an estimate or upper limit on a contract would assist to ensure members can better understand the nature of the financial benefit.

To comply with section 290-10(e) of the CATSI Act the explanatory statement requires the inclusion of:

- all other information that is reasonably required by members in order to decide whether or not it is in the corporation's interests to pass the proposal; and
- all other information that is known to the corporation or to any of its directors.

The corporation should consider if the disclosure of materials relating to this decision to members in the explanatory statement fully reflects these requirements. In this respect the corporation can have regard to 'ORIC Policy Statement 9: Member approval for related party benefits' to consider what is typically required to ensure members are fully informed about the consequences of a related party benefits proposal.

I note that sections 265-1 and 265-5 require officers involved in the preparation of explanatory statements to exercise care and diligence in the preparation of explanatory statements to ensure members can make an informed decision on each proposed benefit.
